EXECUTIVE ORDER NO. 015 2013

AN ORDER AMENDING EXECUTIVE ORDER 007-2005 CREATING THE AMERICAN SAMOA GOVERNMENT SPORTS COMPLEX MANAGEMENT OFFICE, AND DESIGNATING THE DEPARTMENT OF PARKS AND RECREATION AS THE AGENCY RESPONSIBLE FOR MANAGEMENT OF THE FAGATOGO PAVILION

Section 1: Authority

This executive order is issued in accordance with the powers and authority granted to the Governor by Article IV, Sections 6 and 7 of the Revised Constitution of American Samoa, and the American Samoa Code Annotated, § 4.0111(a).

Section 2: Purpose

Executive Order 007-2005 created the American Samoa Government Sports Complex Management Office, and placed a number of government facilities under its supervision, including the Fagatogo Pavilion. The Fagatogo Pavilion is located on the Fagatogo Malae, "Malaeoletalu", which is under the jurisdiction of the Department of Parks and Recreation. The restrooms located adjacent to the Pavilion are managed by the Department of Commerce.

This mixed management of what amounts to a single community facility is costly and inefficient. The purpose of this Executive Order is to delete reference to the Fagatogo Pavilion in Executive Order 007-2005, and to consolidate the different management functions related to the Pavilion under a single agency, the Department of Parks and Recreation.

Section 3: Order

a. Section 3.A of Executive Order 007-2005 is hereby amended to delete any reference to the Fagatogo Pavilion.

b. Responsibility for management of the Fagatogo Pavilion, the Fagatogo Malae, and the restrooms adjacent to the Pavilion, is vested in the Department of Parks and Recreation.

c. The Department of Parks and Recreation shall administer the Fagatogo Pavilion and related assets in accord with the provisions of Title 18, American Samoa Code Annotated.

Section 3: Effective Date

This order shall take effect immediately.
