**EXECUTIVE ORDER NO. 017 - 2013**

**AN EXECUTIVE ORDER AMENDING EXECUTIVE ORDER NO. 014-2013  
TO ADD AN ADDITIONAL MEMBER TO THE AMERICAN SAMOA ECONOMIC  
DEVELOPMENT IMPLEMENTATION PLAN TASK FORCE AND CONFIRMING  
THE LEGISLATURE'S DESIGNEES TO THE TASK FORCE**

**Section 1. Authority**

This Executive Order is issued under the authority granted to the Governor in Article IV, Sections 6 and 7 of the Revised Constitution of American Samoa and the American Samoa Code Annotated Section 4.011.

**Section 2. Preamble**

To ensure the interests of the Manu'a people are fully represented on the American Samoa Economic Development Implementation Plan Task Force, and to further ensure the efforts of the Task Force are coordinated with those already underway as a result of the government's initiative to revitalize the Manu'a Islands, it is appropriate to appoint an additional member to the Task Force to accomplish these goals.

Furthermore, the Legislature's designations having been made, it is appropriate to confirm the designee's membership in the Task Force

**Section 3. Amendment of Section 4.b. of Executive Order 014-2013.**

Section 4.b. of Executive Order 014-2013 is hereby amended to add HTC Le'i Sonny Thompson as a member of the American Samoa Economic Development Implementation Plan Task Force, as an additional representative of the Public Sector. The Task Force is now constituted as follows:
