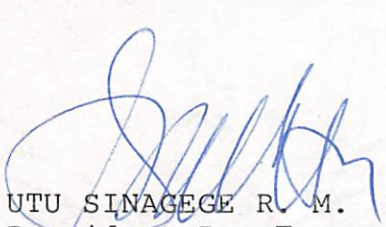
AN ACT ESTABLISHING AN OFFICE EXPENSE FUND FOR THE MEMBERS OF
THE LEGISLATURE; CREATING A NEW SECTION 2.0104 ASCA."

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. There is created a new section 2.0104 which reads:

"2.0104 Office expense fund for Legislators.

Beginning with the Twentieth Legislature, there shall be paid to each member of the Legislature in equal biweekly installments an expense allowance of \$5,000 per annum; and for the President of the Senate and Speaker of the House of Representatives an expense allowance of \$10,000 per annum. This allowance is for the purpose of defraying expenses relating to or resulting from the discharge of their official duties. No accounting of the expense other than for income tax purposes is required."

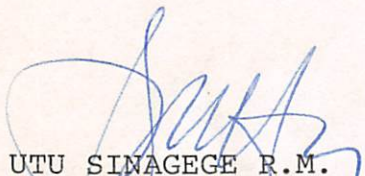

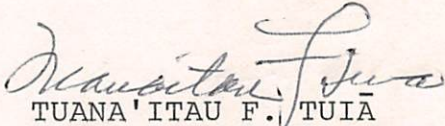

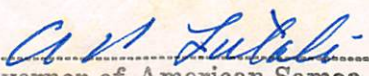
