



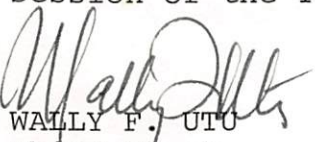

AN ACT APPROPRIATING \$25,000 FROM UNBUDGETED AND UNOBLIGATED
REVENUE OF FISCAL YEAR 1988 TO THE DEPARTMENT OF TREASURY FOR
PAYMENT OF DEATH BENEFITS TO THE WIFE AND CHILDREN OF AFATASI
TOGAFAU, WHO DIED WHILE ON DUTY DRIVING A SCHOOL BUS."

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of funds.

There is appropriated from unbudgeted and unobligated
funds of fiscal year 1988 the amount of \$25,000 to the Depart-
ment of Treasury for payment of death benefits to the wife
and children of Afatasi Togafau.

Any funds remaining unexpended and unobligated at the end
of the period authorized by this act revert to the general fund
and may not be expended or obligated without subsequent appro-
priation by the Legislature.

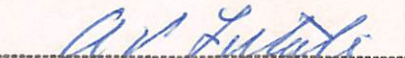
