AN ACT APPROPRIATING THE SUM OF ONE HUNDRED AND FIFTY THOUSAND DOLLARS, AND NO CENTS (\$150,000.00) AS ADDITIONAL FUNDING FOR THE AMERICAN SAMOA FUTURE POLITICAL STATUS STUDY COMMISSION; FUNDING FOR THIS APPROPRIATION SHALL BE PROVIDED FROM THE UNAPPROPRIATED AND UNOBLIGATED REVENUES OF FISCAL YEAR 2006.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue.

There is appropriated the sum of one hundred and fifty thousand dollars (\$150,000.00) to be used as additional funding for the American Samoa Future Political Status Study Commission. The Commission shall use the funds only for purposes and activities necessary and/or related to the fulfilling of its duties and obligations as mandated by Public Law No. 29-6, and as amended by Public Law No. 29-24.

Sec 2. Source of funding.

Funding for this appropriation shall be made available from the unappropriated and unobligated revenues of Fiscal Year 2006.
