AN ACT APPROPRIATING THE SUM OF \$900,000 TO SUPPLEMENT THE  
FY-2007 BUDGET TO FUND THE AMERICAN SAMOA GOVERNMENT  
OPERATIONS.”

Preamble:

Due to the urgent need to provide funding for necessary and proper functions that will be carried out in the current fiscal year, this law shall become effective immediately upon passage by the Legislature and approval by the Governor.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

## Section 1. Appropriation of revenue.




