
AN ACT APPROPRIATING FROM FISCAL YEAR 1988 REVISED ESTIMATED
LOCAL REVENUES THE SUM OF \$25,000 TO PAY THE SETTLEMENT OF A
WRONGFUL DEATH ACTION AGAINST THE GOVERNMENT.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. There is appropriated from fiscal year 1988 revised
estimated local revenues the sum of \$25,000 to the Department
of Treasury to be used only to pay the settlement of the wrong-
ful death action in the High Court of American Samoa, Civil
Action No. 96-86, brought by the estate of Sosaia Mahe against
the government.






