AN ACT APPROPRIATING THE SUM OF \$60,000 FROM THE BUDGET OF THE DEPARTMENT OF LEGAL AFFAIRS, CLAIMS AND DAMAGES FUND NO. 100790, TO PAY IN FULL THE SETTLEMENT AGREEMENT ENTERED INTO AS A RESOLUTION OF A TORT CLAIM BROUGHT BY LYNETTE AND RODERICK ATAFUA AGAINST THE AMERICAN SAMOA GOVERNMENT AND L.B.J. TROPICAL MEDICAL CENTER.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue.

There is appropriated the sum of \$60,000 from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790, for the purpose of full payment of the Settlement Agreement entered into as a resolution of a tort claim brought by Lynette and Roderick Atafua against the American Samoa Government and L.B.J. Tropical Medical Center.

Sec 2. Source of funding.

Funds in the amount of \$60,000.00 shall be payable from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790.
