AN ACT APPROPRIATING THE SUM OF \$140,000 FROM THE BUDGET OF THE DEPARTMENT OF LEGAL AFFAIRS, CLAIMS AND DAMAGES FUND NO. 100790, TO PAY IN FULL THE SETTLEMENT AGREEMENT ENTERED INTO AS A RESOLUTION OF LITIGATION ENTITLED MIRIAMA FAASAVALU V. AMERICAN SAMOA GOVERNMENT AND L.B.J. TROPICAL MEDICAL CENTER, IN HIGH COURT CIVIL ACTION NO. 82-2003.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue.

There is appropriated the sum of \$140,000 from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790, for the purpose of full payment of the Settlement Agreement entered into as a resolution of litigation entitled MIRIAMA FAASAVALU v. AMERICAN SAMOA GOVERNMENT AND L.B.J. TROPICAL MEDICAL CENTER, in High Court civil Action No. 82-2003.

Sec 2. Source of funding.

Funds in the amount of \$140,000.00 shall be payable from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790.
