AN ACT APPROPRIATING THE SUM OF \$500,000.00 FOR CONTINGENT USE TO RESOLVE ISSUES FACING TRANSPORTATION SERVICE IN THE TERRITORY AND PROVIDING FOR AN EARLY EFFECTIVE DATE.

Preamble:

Due to the urgent need to address critical issues facing transportation service in the Territory, which jeopardizes service to the Manu'a Islands, this act shall be effective immediately upon passage by the Legislature and approval by the Governor.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue.

There is appropriated the sum of \$500,000.00 for the following purposes:


To resolve issues which jeopardize continuous transportation service to the Manu'a Islands.

Sec 2. Source of funding.


Funds of \$500,000.00 shall be made available to the Office of the Governor from the State Fiscal Relief funds and may be expended in the Governor's discretion to resolve the issues.

Sec 3. Effective date.

Due to the urgent need to address critical issues facing air transportation service in the Territory, which jeopardizes service to the Manu'a Islands, this act shall be effective immediately upon passage by the Legislature and approval by the Governor.




