

THE THIRTY-SEVENTH LEGISLATURE OF AMERICAN SAMOA

Second Regular Session

Begun and held at Fagatogo, Tutuila, American Samoa on Monday, the twelfth day of July two thousand and twenty one

AN ACT APPROPRIATING THE SUM OF \$254,707.06 FROM THE ASG TRAFFIC REHABILITATION ACCOUNT FOR THE PURCHASE OF VEHICLE AND EQUIPMENT TO SUPPORT TRAFFIC ENFORCEMENT.

Preamble:

WHEREAS, the Department of Public Safety desires to purchase four police trucks for \$222,500 to be used for traffic enforcement; and

WHEREAS, the Department of Public Safety purchased a Harley Davidson Motorcycle for \$32,207.06 including shipping for the purpose of enforcement traffic law; and

WHEREAS, code Section 22.0802 established the ASG – Traffic Rehabilitation Account for the purpose of funding traffic safety; and

WHEREAS, the ASG – Traffic Rehabilitation Account has a balance of \$255,576.34 as of August 18, 2021; and

WHEREAS, there is an urgent need to provide for traffic safety to pay for this motorcycle so that additional traffic safety vehicles can be purchased.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue.

There is appropriated the sum of \$254,707.06 to be provided to the Department of Public Safety for the indicated purposes:

1.	For the purchase of police trucks.....	\$222,500.00
2.	To pay for a Harley Davidson motorcycle.....	\$ 32,207.06
	TOTAL.....	\$254,707.06

The source of these funds shall be the ASG – Traffic Rehabilitation Account.

Sec 2. Effective date.

This bill shall become effective immediately upon passage by the Legislature and approval by the Governor due to the urgent need to provide for traffic safety so additional traffic safety vehicles can be purchased.
