AN ACT APPROPRIATING THE SUM OF \$200,000 DOLLARS FROM UNBUDGETED, UNEXPENDED AND UNOBLIGATED REVENUES OF THE AMERICAN SAMOA GOVERNMENT FOR FISCAL YEAR TWO THOUSAND AND NINE TO FUND THE AMERICAN SAMOA GOVERNMENT OFFICE OF THE INDEPENDENT PROSECUTOR.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:


Section 1. Appropriation.


There is appropriated the sum of \$200,000.00, from unbudgeted, unexpended and unobligated revenues of the American Samoa Government for fiscal year two thousand and nine to fund the American Samoa Government Office of the Independent Prosecutor.

Sec 2. Source of funding.

Funds in the amount of \$200,000 shall be made available to the Department of Legal Affairs from unbudgeted, unexpended and unobligated revenues of the American Samoa Government for fiscal year two thousand and nine in order to fund the operations of the American Samoa Government Office of the Independent Prosecutor.


