BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA


Section 1. Appropriation.


There is appropriated the sum of \$70,000.00, from unbudgeted, unexpended and unobligated revenues of the American Samoa Government for fiscal year two thousand and nine to increase the funding of the Territorial Audit Office.

Sec 2. Source of Funding.

Funds in the amount of \$70,000 shall be made available to the Territorial Audit Office from unbudgeted, unexpended and unobligated revenues of the American Samoa Government for fiscal year two thousand and nine.




