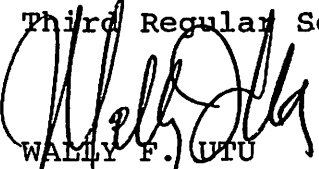

AN ACT APPROPRIATING \$50,000 FROM UNBUDGETED AND UNOBLIGATED
REVENUE OF FISCAL YEAR 1988 TO THE LEGISLATURE TO HOST THE
GENERAL ASSEMBLY OF THE ASSOCIATION OF PACIFIC ISLAND LEGIS-
LATURES AND TO COMMEMORATE THE LEGISLATURE'S 40TH YEAR.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of funds.

There is appropriated from unbudgeted and unobligated
funds of fiscal year 1988 the amount of \$50,000 to the Legis-
lature for the purpose of hosting the General Assembly of the
Association of Pacific Island Legislatures and to commemorate
the 40th Anniversary of the Legislature.

Any funds remaining unexpended and unobligated at the end
of fiscal year 1988 shall revert to the general fund and may
not be expended or obligated without subsequent appropriation
by the Legislature.

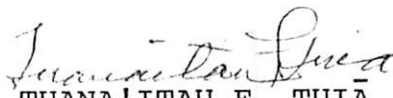
