AN ACT APPROPRIATING THE SUM OF APPROPRIATING THE SUM OF \$22,000,000 FROM UNOBLIGATED AND UNEXPENDED REVENUES FROM FISCAL YEAR 2022 TO SUPPLEMENT THE FISCAL YEAR 2024 BUDGET AND PROVIDING FOR AN EARLY EFFECTIVE DATE.

Preamble:

Due to the urgent need to assist in providing adequate funding for government operations, this act shall be effective immediately upon passage by the Legislature and approval by the Governor.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue:

There is appropriated the sum of \$ 22,000,000 to the following agencies for the indicated purposes:

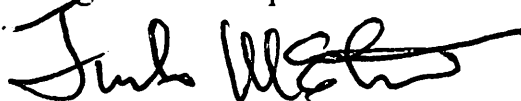

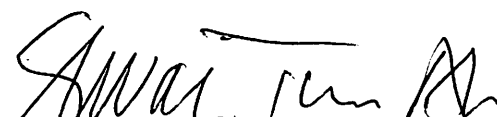
Sec 2. Source of funding.

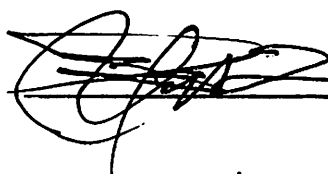
Funds of \$22,000,000 shall be made available to the respective departments and agencies from unbudgeted, unobligated, and unexpended revenues from Fiscal Year 2022.

Sec 3. Effective date.

This Act shall become effective immediately upon passage by the Legislature and approval by the Governor due to the urgent need to assist in providing adequate funding for government operations.

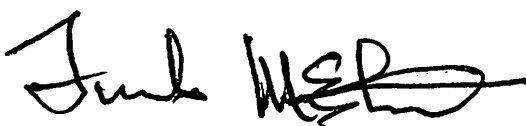

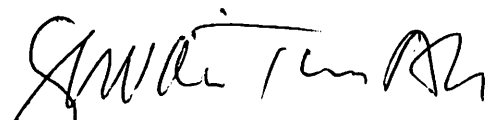
