AN ACT APPROPRIATING THE SUM OF \$147,230 DOLLARS, PLUS POST JUDGMENT INTEREST, FROM THE BUDGET OF THE DEPARTMENT OF LEGAL AFFAIRS, CLAIMS AND DAMAGES FUND NO. 100790 FOR THE PAYMENT OF AN OUTSTANDING JUDGMENT ENTERED BY THE HIGH COURT OF AMERICAN SAMOA ON SEPTEMBER 21, 2006 IN THE CASE OF LEASUASU TUPONO V. AMERICAN SAMOA GOVERNMENT, CIVIL ACTION NO. 100-2003.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation.

There is appropriated the sum of \$147,230.00 plus post judgment interest, from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790 for the payment of an outstanding judgment entered by the High Court of American Samoa, Trial Division, on September 21, 2006 in the matter of Leasuasu Tupono v. American Samoa Government, Civil Action No. 100-2003.

Sec 2. Source of funding.

Payment shall be made from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790 from unbudgeted and

unexpended revenues of the American Samoa Government for Fiscal Year 2008 and any subsequent fiscal years until such time as all amounts due pursuant to the judgment are satisfied.
