AN ACT GRANTING POWER, THE POWER TO SELECT THE PRESIDENT OF THE AMERICAN SAMOA COMMUNITY COLLEGE TO THE BOARD OF HIGHER EDUCATION; AMENDING SECTION 16.2005 OF TITLE 16 A.S.C.A.”

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. 16.2005 is amended to read:

“16.2005 President of the college.


~~The board of higher education shall recommend to the Governor a list of three candidates, in the order of descending priority, who have received the highest consideration of the board. The Governor shall appoint the president of the college only from the proffered list of recommendations. Subject to government employee laws 7.0101 et. seq., and rules and procedures of the college, the President serves at the pleasure of the Board.~~

The board of higher education shall select the President of the college. The selection of the President shall conform to rules, regulations and criteria promulgated by the board and made available for public inspection. Subject to government employee laws 7.0101 et. seq., and rules and procedures of the college, the President serves at the pleasure of the Board.”
