AN ACT APPROPRIATING THE SUM OF \$257,817.13, PLUS POST JUDGMENT INTEREST, FROM THE BUDGET OF THE DEPARTMENT OF LEGAL AFFAIRS, CLAIMS AND DAMAGES FUND NO. 100790 FOR THE PAYMENT OF AN OUTSTANDING JUDGMENT ENTERED BY THE HIGH COURT OF AMERICAN SAMOA ON JULY 13, 2001 IN THE CASE OF GIBBONS V. AMERICAN SAMOA GOVERNMENT, CIVIL ACTION NO. 128-93.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation.

There is appropriated the sum of \$257,817.13 plus post judgment interest, from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790 for the payment of an outstanding judgment entered by the High Court of American Samoa, Trial Division, on July 13, 2001 in the matter of Gibbons v. American Samoa Government, Civil Action No. 128-93.

Sec 2. Source of funding.

Payment shall be made from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790.
