BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA


Section 1. Appropriation.


There is appropriated the sum of \$100,000.00, from unbudgeted, unexpended and unobligated revenues of the American Samoa Government for fiscal year two thousand and nine to fund the Office of the Internal Auditor.

Sec 2. Source of Funding.

Funds in the amount of \$100,000 shall be made available to the Department of the Treasury from unbudgeted, unexpended and unobligated revenues of the American Samoa Government for fiscal year two thousand and nine in order to fund the Office of the Internal Auditor.
