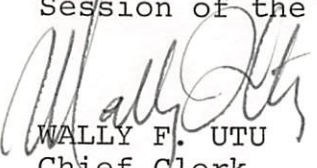

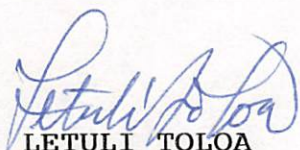

AN ACT APPROPRIATING \$50,000 FROM REVISED ESTIMATED LOCAL REVENUES OF FISCAL YEAR 1988 TO PAY THE SETTLEMENT OF A WRONGFUL DEATH ACTION AGAINST THE GOVERNMENT.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. There is appropriated from fiscal year 1988 revised estimated local revenues the sum of \$50,000 to the Department of Treasury to be used only to pay the settlement of the wrongful death action in the High Court of American Samoa, Civil Action No. 123-87, brought by the estate of Pili Aoelua, against the Government.

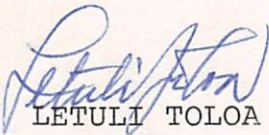
