AN ACT APPROPRIATING THE SUM OF \$3,100,000.00 TO SUPPLEMENT  
THE FY-2003 BUDGET AND PROVIDING FOR AN EARLY EFFECTIVE  
DATE.

Preamble:

Due to the urgent need to assist in providing adequate funding for  
government operations and achieve a balanced budget for FY-2003, this act shall  
be effective immediately upon passage by the Legislature and approval by the  
Governor.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

**Section 1. Appropriation of revenue.**

There is appropriated the sum of \$3,100,000.00 for the following  
purposes:

<b>Legislature Overruns</b>	<b>\$1,000,000.00</b>
<b>Department of Port Administration (Airport Overruns)</b>	<b>\$ 500,000.00</b>
<b>Debt Service (Omitted from Budget)</b>	<b><u>\$1,600,000.00</u></b>
<b>Total</b>	<b>\$3,100,000.00</b>

**Sec 2. Source of funding.**

Funds of \$3,100,000.00 shall be made available to the Legislature and  
respective departments for this act by amending A.S.C.A. Section 11.1002 to  
delete provisions of the deficiency reduction fund and applying accumulated  
revenues to the general fund:

Legislature	Budget Overruns	\$1,000,000.00
Port Administration	Airport Overruns	\$ 500,000.00
Treasury	Debt Service	<u>\$1,600,000.00</u>
Total		\$3,100,000.00

**Sec 3. Effective date.**
