AN ACT APPROPRIATING THE SUM OF \$80,000 FROM THE BUDGET OF THE DEPARTMENT OF LEGAL AFFAIRS, CLAIMS AND DAMAGES FUND NO. 100790, TO PAY IN FULL THE SETTLEMENT AGREEMENT ENTERED INTO AS A RESOLUTION OF LITIGATION ENTITLED FONOMAITU LUTU ET. AL. V. ASG AND LBJ TROPICAL MEDICAL CENTER, IN HIGH COURT CIVIL ACTION NO. 110-2003.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue.

There is appropriated the sum of \$80,000 from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790, for the purpose of full payment of the Settlement Agreement entered into as a resolution of litigation entitled Fonomaitu Lutu et. al. v. ASG and LBJ Tropical Medical Center, in High Court Civil Action No. 110-2003.

Funds in the amount of \$80,000.00 shall be payable from the budget of the Department of Legal Affairs, Claims and Damages Fund, No. 100790.
