AN ACT APPROPRIATING \$75,000 FROM UNBUDGETED AND UNOBLIGATED
REVENUE OF FISCAL YEAR 1988 FOR THE BENEFICIARIES OF THE VIC-
TIMS OF THE AUNU'U BOAT ACCIDENT.


BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. There is appropriated from unbudgeted and unobli-
gated revenue of fiscal year 1988 the amount of \$75,000 to the
Treasurer of American Samoa. The funds shall be paid to the
families or beneficiaries of the Aunu'u Boat Accident victims
as follows:


