AN ACT APPROPRIATING EXCESS REVENUES FROM FY2003 IN THE
SUM OF \$1,460,000.00 AND PROVIDING FOR AN EARLY EFFECTIVE
DATE.

Preamble:

Due to the urgent need to pay the ASG Property and Casualty Insurance premium for 2004; facilitate the preparations for the Flag Day and Celebration for the Centennial of the Manu'a Treaty and Flag raising; to upgrade the Fono personnel that was not part of the Reclassification of ASG; the publication of the American Samoa Code and other projects of the Fono, this act shall be effective immediately upon passage by the Legislature and approval by the Governor.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. Appropriation of revenue.

There is appropriated the sum of \$1,460,000.00 for the following purposes:

Office of the Governor (for Property Insurance Premium and to pay Flag Day and Manu'a Centennial Expenses)	\$1,060,000.00
To support Select Senate Investigation Committee	30,000.00
Legislature of American Samoa (for upgrading personnel and office expenditure; upgrading information system);	<u>370,000.00</u>
Total	\$1,460,000.00


Sec 2. Source of funding.


Funds of \$1,460,000.00 from the excess revenues of FY 2003 shall be made available to the Office of the Governor and the Legislature to apply as follows






