AN ACT PROVIDING FOR CONSISTENT QUORUM REQUIREMENTS IN THE HIGH COURT FOR JURY TRIALS AND CLARIFYING THAT JURY TRIALS HELD IN DISTRICT COURT SHALL BE CONDUCTED BY THE DISTRICT COURT JUDGE SITTING ALONE; AMENDING SECTIONS 3.0232 AND 3.0303 A.S.C.A.

Preamble:

This Act is effective immediately upon passage by the Legislature and approval by the Governor due to the emergency need to conserve High Court judicial resources.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. 3.0232 is amended to read:

“3.0232 Trial division—Petit jury.

(a) Any person charged with an offense carrying a maximum possible punishment of over 6 months of imprisonment shall be tried by a jury unless he personally waives this right in writing or in open court. The Chief Justice of the High Court may promulgate Petit Jury Rules and Standard Jury Instructions to govern jury trials in the High Court and District Court. The petit jury shall be comprised of 6 persons. The jury verdict must be unanimous. Voir dire of prospective jurors shall be conducted by the court.

(b) ~~Notwithstanding any law to the contrary;~~ Whenever petit jury trials are held as provided in subsection (a), 2 at least 1 associate judges shall sit with either the Chief Justice, or Associate Justice, or Acting Associate Justice, who acts as presiding judge of the court High Court. All questions of law shall be ruled upon by the presiding judge.”

Sec 2. 3.0303 is amended to read:

"3.0303 Sessions. -Petit jury.

(a) All sessions of the District Court are conducted by a District Court judge sitting alone.

(b) Sessions of the District Court are held in the Court House in Fagatogo, Tutuila, or at such other places in American Samoa as the business of the court requires and as the Chief Justice may designate from time to time.

(c) A person charged with an offense carrying a maximum possible punishment of over 6 months but not more than one year of imprisonment shall be tried by a jury unless he personally waives this right in writing or in open court. The petit jury shall be comprised of 6 persons. The jury verdict must be unanimous. Voir dire of prospective jurors shall be conducted by the court.

(d) Whenever petit jury trials are held in District Court as provided in subsection (c) the District Court judge, as provided in subsection (a), sitting alone acts as presiding judge. All questions of law shall be ruled upon by the presiding judge."

Sec 3. Effective date.

This Act is effective immediately upon passage by the Legislature and approval by the Governor due to the emergency need to conserve High Court judicial resources.
