

THE TWENTY-FIRST LEGISLATURE OF AMERICAN SAMOA

Third Special Session

Begun and held at Fagatogo, Tutuila, American Samoa  
on Monday, the twenty-third day of October  
one thousand nine hundred and eighty nine

AN ACT APPROPRIATING THE SUM OF \$120,000 FROM ESTIMATED REVENUE OF FISCAL YEAR 1990 TO PAY FOR THE APIL DUES AND AMERICAN SAMOA'S SHARE IN THE PACIFIC ISLANDS DEVELOPMENT BANK SHARE.

PREAMBLE:

This measure is urgently needed to fulfill the Government's commitment to pay its APIL dues and its share in the Pacific Islands Development Bank, which justifies an immediate effective date.


BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. There is appropriated from estimated revenue of Fiscal Year 1990 the sum of \$120,000 to the Legislature. The Legislature shall use the funds solely to pay its APIL dues in the amount of \$20,000; and the American Samoa share in the Pacific Islands Development Bank in the amount of \$100,000.


Sec 2. Effective date.

This law becomes effective upon passage by the Legislature and approval by the Governor.
