





THE TWENTY-FIRST LEGISLATURE OF AMERICAN SAMOA

AN ACT APPROPRIATING THE SUM OF \$25,000 FROM UNBUDGETED AND UNOBLIGATED REVENUE OF FISCAL YEAR 1989 TO PAY FOR THE LAGITAO WRONGFUL DEATH CLAIM AGAINST THE AMERICAN SAMOA GOVERNMENT.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. There is appropriated from unbudgeted and unobligated revenue of Fiscal Year 1989 the sum of \$25,000 to the Treasurer. The Treasurer shall use the funds solely to pay the settlement of the Lagitao wrongful death claim, Civil Action 119-85, against the American Samoa Government.
